


VBCOA Permit Technician Committee





Proposed Code Addition to define Permit Technicians duties and require the certification.

Based on the survey comments and the consensus at local Region V, the code change will be discussed at the final Work group meeting on April 11th.

Please see the below wording:

Previous proposed code change: DRAFT

Definitions-Section 202

TECHNICAL ASSISTANT. Any person employed by or under an extended contract to a local building department or local enforcing agency for enforcing the USBC, including but not limited to inspectors, plan reviewers and individuals who review, process and issue building or trade permits. For the purpose of this definition, an extended contract shall be a contract with an aggregate term of 18 months or longer.


105.2.1 Qualifications of technical assistants.

A technical assistant shall have at least three years of experience and general knowledge in at least one of the following areas: building construction or building construction conceptual processes, building, fire or housing inspections; plumbing, electrical or mechanical trades; or fire protection, elevator or property maintenance work. Any combination of education and experience that would confer equivalent knowledge and ability shall be deemed to satisfy this requirement. The locality may establish additional qualification requirements.
