 - New wind speeds in the 2015 Virginia Residential Code; Figure R301.2(4)A; conversion from V(ult) to nominal speed discussed; Travis Luter from DHCD spoke on the topic; any member with questions or concerns should contact DHCD
 - Lumber grading requirements for sawn lumber (R502.1.1; R602.1.1; R802.1.1)
 - Travis Luter from DHCD provided update from DHCD-State Building Code's Office; a recent ruling from the SBCTRB regarding school safety, the USBC and the SFPC was discussed (additional info and the ruling is available online or by contacting DHCD)
